What is a Relief Chest?

> It is a charitable account that is owned collectively by a group of Freemasons to manage their charitable giving.

> The Scheme was set up in 1986 by the Freemasons' Grand Charity (registered charity 281942) to receive and deposit donations, reclaim Gift Aid tax and to make payments to charities.



➤ On average each year, the scheme receives over £11million in donations including over £1million in Gift Aid tax relief into Relief Chests.

> Each year, the chest holders donate over £12million from Relief Chests to various registered charities and appeals including some relief of distress payment.
